EU-Turkey relations:

Wake up call from the business community

The business world remains unimpressed by the often adverse political conditions in the EU-Turkey relationship as seen in two unique and detailed surveys published by EUROCHAMBRES and TOBB. According to the survey among 3700 companies in Turkey, 3/4 of Turkish companies are strongly in favour of joining the EU. A mirror survey among 1700 European companies stresses that European companies show a strong interest in enhancing EU-Turkey relationship, even if they are more divided regarding the impact of Turkey's potential entry.

Both surveys were presented in a conference on 10 April in Brussels with the participation of Mevlüt Çavuşoğlu, Turkish Minister for EU Affairs and Chief Negotiator.

The surveys have also highlighted the optimism of companies regarding the entry date of Turkey to the EU. More than half of the companies in both regions believe that Turkey will join the EU by 2023, European companies being even more optimistic - only 8% consider that Turkey will never join the EU against 28% of the Turkish companies.

Commenting on these findings during the conference in Brussels, M. Rifat Hisarcıklıoğlu, Deputy President of EUROCHAMBRES, and President of TOBB, said: "The results of the surveys are quite remarkable. Nevertheless the findings of the survey among Turkish companies call for further efforts to ensure that information on the acquis as well as on the overall accession process is reached by the largest number of Turkish companies. A lack of information may lead not only un-preparedness to cope with the Single Market, but also to mistrust vis-à-vis the accession process".

Arnaldo Abruzzini, Secretary General of EUROCHAMBRES concluded the conference adding: "The EU-Turkey relationship is based on a strong and deep economic integration. The success of the Customs Union between the EU and Turkey is undeniable but it should be modernised, its functioning should be improved, and its scope expanded. These massive mutual economic interest and benefits should be better reported and acknowledged".

The surveys were carried out in the framework of the second phase of the EU-Turkey Chambers Forum (ETCF II). <u>ETCF II</u> is a three-year project implemented by EUROCHAMBRES and the Union of Chambers and Commodity Exchanges of Turkey (TOBB).
