## SMEs untapped potential in EU-Russia Relations

Ahead of the EU-Russia Summit of 9 June, EUROCHAMBRES, including its Russian member, the Chamber of Commerce and Industry of the Russian Federation, and AEB, the Association of European Business in Russia, would like to call on government leaders to put more emphasis on the potential of small and medium sized (SME) business to strengthen EU-Russia relations.

Statistics show that the SME sector in the Russian economy has an important potential and is constantly expanding. The Russian Federation has 1,7 million SMEs and over 4 million individual entrepreneurs, which produce 21% of GDP. Nearly 17 million people have been employed by SMEs. However, only 5% of those SMEs have international contacts, which is a serious problem for their long-term competitiveness.

Within the European Union, there is a similar need to increase efforts to promote the internationalisation of SMEs. Trade and investment relations with Russia remain underdeveloped; in particular SMEs with a strong innovation capacity should have an important potential on the Russian market.

"Bringing more SMEs into EU-Russia trade requires an effort on both sides: capacity building measures for SMEs and their representative organisations, but also strengthening the regulatory environment for doing business", explained Arnaldo Abruzzini, EUROCHAMBRES' Secretary General.

Dr. Frank Schauff, CEO of AEB added, "Trying to support EU-Russian business on a daily basis, we can confirm the challenges for SMEs are important, for both sides. Our respective governments have a responsibility to facilitate that process."
