## Bulgarian framework

- Refugees and migrants need to upgrade their skills and qualification, knowledge of Bulgarian language in order to meet the requirements of the employers.
- There is a readiness and willingness on the part of the employers to support the refugees in this learning process, provided they are motivated to invest efforts and commit to the company's goals and mission.
- The most appropriate job opportunities for refugees will be in the processing industry, the food and accommodation, the transport and construction sectors, the agricultural sector in various geographical and economic regions in Bulgaria.
